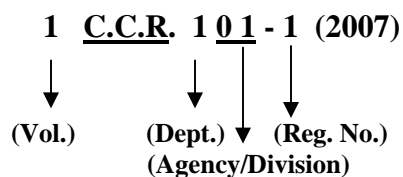




Administrative Law: Colorado

Colorado regulations are rules or orders issued by state government and administrative agencies to direct the activities of their employees and implement corresponding statutes. CURRENT & HISTORICAL REGULATIONS IN UNOFFICIAL C.C.R.:

The unofficial C.C.R. is compiled, edited, and published by Matthew Bender & Co., Inc., an affiliate of LexisNexis. Use the following research tips to find current and historical regulations in the unofficial publication.

1. If you have a C.C.R. citation, check the appropriate binder volume on the shelf.
Level 3 KFC 1835 1977 .A22.
(**Note:** As C.C.R. is amended, revised text for the regulation(s) affected will be inserted in the proper loose-leaf volume(s).)

2. If you have a related Colorado statute citation, check West's Colorado Revised Statutes Annotated (West's Colo. Rev. Stat. Ann.). **Level 3 KFC 1830 1989 .A2.**
(**Note:** This publication **may** feature a corresponding C.C.R. citation in annotations following the statute text.)

3. If you do **not** a Colorado regulation citation, but have the name of a Colorado administrative agency department or division: use the “Table of Contents for THE CODE OF COLORADO REGULATIONS” in C.C.R. Index. Level 3 KFC 1835 1977.A22 INDEX.

4. If you do **not** have a Colorado regulation citation, use the “Alphabetical Topical Index for THE CODE OF COLORADO REGULATIONS” in C.C.R. Index. Level 3 KFC 1835 1977.A22 INDEX.

UPDATING THE C.C.R. IN UNOFFICIAL C.R.:

The C.R. (Level 3 KFC 1835.A231) is published monthly and divided into three parts:

- Current Proposed Regulations (3 volumes)
- Current Attorney General (A.G.) Opinions
- Digest of Current Developments

See the Current Proposed Regulations volume and monitor monthly blue “FILING INSTRUCTIONS NOTICE OF RULEMAKING AND PROPOSED REGULATIONS AND ATTORNEY GENERAL OPINIONS” sheets for updates.
