UBE Summer 2024 Sample Lecture Schedule

This sample schedule provides you with a weekly view of general sequencing throughout BARBRI Bar Review. This schedule does not represent all assignments that will be provided, you will need to check your Personal Study Plan (PSP) for your full assignment list. Your PSP will be available in mid-April and will have a default start date in mid-May, but you will have the opportunity to customize your calendar and select a start date that is convenient for you. With calendar customization, you will have the opportunity to choose the days of the week you would like to regularly study as well as any specific days you need to take off. Each week, you may study the specific days, hours per day, and time of day that works best for your schedule.

With a mid-May start date, you will spread your studies over a minimum of 8-10 weeks. During this time, you should treat your studies as a full-time job and invest approximately 40 hours each week studying.

Students who customize their calendar with an earlier start date will be able to study fewer hours per day, fewer days per week and/or take more days off throughout their course.
